Community Sergeant Update

August has been another busy month which has seen a further easing of restr.....,, the hospitality sector, extended licensing hours and larger organised events. Schools have also returned and next month will also see students returning to their universities.

Unfortunately the COVID case numbers that we are seeing at the moment is still a cause for concern given that in the last 7 days case numbers have roughly doubled. The safety of everyone is the most important factor and it is vital that we all remember the virus has not gone away and still poses a significant risk to public health and our return to a more normal way of life.

Even basic steps such as wearing face coverings on public transport, opening a window if you have someone in your house to make sure there is good ventilation can still make a big difference.

Please also remember it is still a requirement to wear face coverings in certain indoor public places, such as shops, public transport and when entering and moving about in hospitality settings.

Whilst on the hospitality and retail theme August has also seen a new law come into force in Scotland to provide specific protection for retail workers – it is called the Protection of Workers Act 2021.

It will make it an offence to assault or behave in a threatening or abusive way towards a retail worker. A 'retail worker' could be someone who is works or volunteers in a shop, shopping centre or supermarket. They might be delivering groceries to a house or selling alcohol in a bar.

Assaulting, threatening or being abusive to a retail worker for enforcing age restriction laws e.g. IDing someone trying to buy alcohol, will become an aggravated charge - that means a person convicted may get a tougher penalty. Retail workers are an important part of the community, this new law is being introduced to give them greater protection.

Student Safety

Starting university or college can mean some significant life changes - making new friends, studying in a new town, going out to new places and living independently for the first time. However, some of these changes could also increase your risk of becoming a victim of crime.

Start out in the safest way possible, take some simple steps to protect yourself and your property, and above all keep safe.

Finally, of significant concern in recent weeks has been the spate of wilful fire raisings which have taken place in Walkerburn and involved significant damage to a number of motor vehicles. I can confirm that a male was arrested in relation to these offences, subsequently charged and appeared at Edinburgh Sheriff Court on 30/08/21. Extra police patrols will continue in Walkerburn to offer reassurance but I would ask residents to remain vigilant and report any suspicious activity to police.

Protecting most vulnerable

In August 2021 Police in the Scottish Borders attended and were involved with around 152 mental health related calls, around 26 missing person enquiries and approximately 91 domestic related incidents.

Tweeddale East & West had 6 mental health related calls and 0 missing person enquiries. Due to GDPR and protection of victims/subjects involved, we are unable to share any more specific information in relation to these type of call within this report.

Police Scotland work in collaboration with key partners to assist the most vulnerable within the communities and to provide support.



Reducing violence and ASB

Assaults

On 11/08/21 report of damage being caused to Community Garden Victoria Park Day Centre Peebles and apples being thrown at neighbouring properties. Passed to community policing team for further action.

On 11/08/21 report of disturbance George Street Innerleithen. Police attended no complaints.

On 11/08/21 report of youths throwing stones at vehicles driving past on Kingsmeadows Road Peebles. Passed to community policing team for further action.

On 12/08/21 report of youths banging on doors and windows Broomlee Crescent West Linton. Resident requested no further police action.

On 13/08/21 and 14/08/21 report of noisy party at a property in the Loan West Linton. Police attended, no noise on arrival, occupants advised regarding noise levels. No criminality.

Improving road safety

Tackling serious and organised crime

On 14th of August 2021 officers from the Scottish Borders executed a search warrant at an address in Kelso following numerous local Housebreakings. A male was traced within and arrested and a report was submitted to the Procurator Fiscal.

On 20th of August 2021 officers stopped a vehicle in Hawick. Following a search of the vehicle £80 of Cannabis and 39 Street Diazepam were found within the vehicle. A female was charged and a report will be submitted to the Procurator Fiscal.

On 25th of August 2021 officers from the Scottish Borders Community Action Team executed a drugs search warrant at an address in Hawick. Following a systematic search over 300 street Diazepam was recovered. A report will be submitted to the Procurator Fiscal.

On 27th of August 2021 officers in Galashiels stopped a vehicle, following a search of the vehicle a offensive weapon and a quantity of herbal cannabis were found within. The two male occupants of the vehicle were arrested and a report has been submitted to the Procurator Fiscal.

On 30th of August 2021 officers in Duns stopped a male in the street and had grounds to search him. Following a search they found in his possession an amount of Herbal Cannabis. The male was charged and a report will be submitted to the Procurator Fiscal.

Retail workers are an important part of our country, they should not be hurt, abused or made to feel frightened for doing their job.






Ongoing Divisional Domestic Abuse campaign



CAT Update:

Throughout August SBCAT have undertook a range of activities in line with their monthly tasking identified through the Scottish Borders Community Action Team Strategic Oversight Tasking Group.



ASB – SBCAT have targeted youth ASB in Peebles, Kelso and Hawick throughout August resulting in a number of alcohol seizures and 1 adult being reported to the Procurator Fiscal following being identified as being as supplying alcohol to youths. SBCAT have further made use of the new Scottish Borders Quad bikes to undertake patrols around rural location where youth ASB has been reported. A number of youths were further identified through the youth warning system with letters being sent to their parents in an effort to inform parents of their children's potential involvement in ASB. Officers have further engaged in patrols in the Jedburgh area where a spate of vandalism occurred to the public toilets, patrols were undertook to coincide with the placement of a mobile ASB camera in the area.

Road Safety – SBCAT continue to undertake road checks across the region along with undertaking speed enforcement outside local schools and areas identified as having an accident casualty profile. Officers have further undertook regular patrols in regards to parking restriction enforcement including in the areas of Innerleithen and Galashiels where problems areas have been identified by the public.

Drugs – SBCAT officers continue to undertake intelligence led stop and searches of those suspected to be involved in the supply of controlled drugs, relying on information provided by local communities. SBCAT officers further executed a MDA warrant in Hawick resulting in the recovery of both Class B and C drugs from the property and enquires are ongoing in relation to the recovery.

SBCAT officers have further been assisting with enquiries in Walkerburn following a number of reported suspected fire-raising in the area. Following a further report in the last week of August SBCAT officers reported a 29 year old male for 5 separate counts of Fire-Raising.
