Minutes from the meeting of Tweedsmuir Community Council (TCC) Thursday 7th March at 7pm, Tweedsmuir Village Hall & via ZOOM

Present:

Catriona Patience, Wild Heart Project Officer from Borders Forest Trust joined the meeting via zoom, to update on current projects and volunteering opportunities.

Current projects include:

- upgrading the Barns at Talla and Gameshope to provide a better base for volunteers.
- improving access through the construction of bridges at Gameshope Bothy and Donald's Cleugh.
- tree planting at various sites.
- providing education opportunities e.g. Botanical training, heritage walks and landscape photography.
- increasing interpretation materials including a toposcope at the top of Talla Lins.
- increasing volunteering opportunities e.g. tree planting, at Talla Gameshope every Thursday 10am – 3pm, and 1st Sunday of month.

CH raised the issue of potential grant funding for the provision of bus shelters at Patervan, Stanhope and Kingledores at a cost of approx. \pounds 500 each. This would require a grant application by TCC, to SSE Windfarm Fund.

- **DC** reported having received an email for PC Vivienne Carsley, J Division, Community Policing Team. PC Carsley had expressed a commitment to attend a meeting of each of SBC's Community Council, in person at least one a year and possibly more frequently if meetings were held virtually. Information regarding details of in-person/hybrid meetings was requested and subsequently provided.

• 08.03 Scottish Borders Councillors' report

DB reported that -

- SCB Community Councillor Eric Small was currently on sick leave. TCC expressed their concern for Eric and wished him a speedy recovery.
- SBC has agreed the budget for the coming financial year. There had been positive collaboration across the political parties to reach a consensus in the context of significant financial challenges. This had only been possible by drawing on financial reserves, a strategy which is unfortunately not sustainable in the longer term.
- Waste Management is a particular area of personal interest/ concern and DB had recently been finding out more about the operations of Caledonian horticulture and waste sorting at Levenseat. 11.03 Community Council Website

It was agreed that a document specifying the work needed to upgrade the TCC website is required in order to obtain costings and seek the funding needed to undertake the necessary work. If possible, a local provider would be engaged to carry out the work required.

LM reported that work had commenced on the polytunnel in the Community Garden.

- **MC** sent a report on a meeting arranged by SBC to share information about Planning Processes.

From 2026, SBC has undertaken to consider locality produced 'Local Place Plans' as part of planning applications/processes. After discussion it was agreed that TCC needs to better understand the relationship between Tweedsmuir's Community Action Plan and a Place Plan to ensure the community is not disadvantaged in relation to future planning decisions by the absence of a Place Plan and the work required should a Local Place Plan be felt to be advantageous.

Actions:

DC to contact SBC to gain better understanding of the status of/relationship between CAP and Local Place Plans.

- **CH** raised the issue of the potential need for affordable housing within Tweedsmuir. It was noted that a needs assessment with respect to this had been an action identified within the CAP.
